



## LETTER OF AGREEMENT

This document sets out the relationship between you and us. It sets out what you are required to do, in order to register with Stellenbosch University (“the **University**”) as a student for the 2024 academic year, even though you have outstanding student fees (including registration fees for 2024) that you owe to the University.

### What does this this document set out to do?

- Normally, the University will not allow you to register as a student if you owe the University any fees.
- For the 2024 academic year, the University has decided to allow you to register as a student, even though you owe the University fees, subject to the conditions as described below, being met by you.
- **This arrangement is only for the 2024 academic year and is a once-off concession made by the University. The University does not undertake, guarantee, or create any expectation that similar arrangements will be made in future for you or other students.**

### For you to register as a student at the University for 2024, you must:

- Apply for a student loan with one of the University’s recommended student loan providers within seven (7) days of signing this document via the following link: <https://landbot.pro/v3/H-1648192-V7CAIWW44UWQ6WAN/index.html>
- When applying for a student loan, you must ensure that you do everything that is necessary and submit all relevant information on time for the loan provider to consider

your application and to enable the loan provider to make a decision on whether they are able to provide you with a student loan.

- The University will provide you with a list of recommend student loan providers once you signed this document.
- It remains a requirement that you meet the University's academic requirements and criteria relevant to your programme to register as a student with the University.

**If you do not apply for a student loan or your application for a student loan is unsuccessful, you remain liable for the outstanding fee/debt on your Student Fees account.**

### **What happens if you do not pay the fees you owe the University on time?**

If you do not pay the fees you owe the University on time, the full balance of the outstanding fees you owe will have to be paid by you to the University immediately.

If you do not pay the full amount immediately, the University will be allowed to apply its normal debt collection procedures in terms of the National Credit Act.

### **Arrangements limits**

This document only deals with the current outstanding fees you owe the University and the registration fees for 2024.

This arrangement is subject to you meeting the University's academic requirements and criteria relevant to your programme, to qualify for registration as a student.
