ACCEPT (or reject) the bursary.

You will receive a notification on SUNStudent to either accept or reject the NSFAS 2024 bursary. Next steps:

- **LOG ON to SUNStudent**

To proceed with accepting or rejecting the bursary, log on to the SUNStudent portal and follow the steps to Fees/Bursaries to make your selection.

- **ACCEPT THE BURSARY**

If you accept the funding, download and complete the FORM Bursary Acceptance. It can be found here: Forms & Policy > NSFAS section.

Upload the signed form to your SUNStudent profile.

If you are unable to upload the form, please provide a printed copy to Student Fees Client Services in Admin A as soon as possible. For **Tygerberg campus students**, please drop off a copy at Room 1044, Clinical Building.

Living arrangements.

Once you have uploaded the FORM Bursary Acceptance, do the following:

- **CONFIRM YOUR LIVING ARRANGEMENTS (accommodation)**
If you live at home or in private accommodation, please make sure your living arrangements are updated and correct on SUNStudent > MyProfile > Living Arrangements.
Students who live in private accommodation will be required to upload their signed lease agreement.
- **DOUBLE-CHECK YOUR SUNStudent PROFILE DATA**
Please make sure all your contact details are correct on your profile, especially your cell phone number.
We recommend you keep the same cell phone number for 2024 as any changes may impact on you receiving your allowances timeously due to additional administration.

NO ACCOMMODATION CHANGES ARE ALLOWED DURING 2024

Intellimali payment process.

The last step in the bursary acceptance process is making sure your Intellimali account is activated to receive your allowance payments.

Once your first payment has been loaded, you will receive a PIN from Intellimali – this will be sent to your registered cell phone number. Follow these 5 steps:

- i** **LOG IN** to your Intellimali account using your ID number (username) and the PIN that was sent to your cell phone/email address. Please double-check that your email address is correct (so you can receive the verification email); if not, please email info@intellimali.co.za with the correct details.

- ii** **CLICK ON MENU** and select Banking. Complete all the relevant fields with your banking information – but **do not change** the branch code (this will be automatically populated) – then click Update.
- iii** **ENTER PASSWORD** You will be prompted to enter your password (the one you used when you signed in for the first time). If you have forgotten your password, please use the Reset Password option, found under MyDetails.
- iv** **SAVE YOUR CHANGES** Once you have saved any changes, you will be prompted to verify your details by clicking on a link; this will activate an email to your mailbox.

DO NOT CLICK THE CANCEL VERIFICATION BUTTON in step iv, as you will then have to restart the process to verify your Intellimali account

- V** **VERIFY YOUR DETAILS** Go to your mailbox and find the email from Intellimali containing the verification link.
Click on the link to verify your details. A Verification Successful page should appear. The process has then been concluded and no further action is required on your part.

24 – 28 HOURS for the validation of your bank details to be processed
24 – 28 HOURS for a payment to reflect in your bank account.

PROCESSING of book & accommodation allowances.

The initial funding amount will only reflect the book allowance; this will be updated as soon as we have calculated your cost of attendance* (study) based on the 2024 NSFAS guidelines.

- The payment of the book allowance will only be processed *after* you have completed and submitted the FORM Bursary Acceptance.
- SU will only manage the book allowance and rental allowance payments process, while NSFAS third-party service providers will manage the payment of the remaining allowances, that is, including living (meals), transport, and personal care/incidental allowances.

*** COST OF ATTENDANCE (STUDY)** *is a combination of costs that includes tuition fees, accommodation, meals, study materials, and travel (the latter strictly associated with a student's studies and based on a student's circumstance and living arrangement*

ACCOMMODATION CHANGES & allowance CAP.

- The NSFAS accommodation allowance is capped at R50 000 (Stellenbosch campus; 10 months) and R50 000 (Tygerberg campus; 11 months). SU accommodation ranges from between R64 000 and R68 000 per academic year.
- NSFAS use a third-party service provider to disburse allowances (make payments). It is imperative that every student provides correct and updated info about their living arrangements on SUNStudent *before submission*.

CHANGES IN ACCOMMODATION ARE NOT PERMITTED (and the SUNSurvey is no longer applicable)

DOUBLE-DIPPING* & bursary cancellation.

- If a student receives any other funding or full cost bursary, **NSFAS and CUBL must be informed** of this.
- **TO CANCEL YOUR NSFAS BURSARY**
You will need to download and complete the FORM Bursary Cancellation. It can be found here: [Forms & Policy](#) > Bursary Awarded section.

Remember to also inform NSFAS of your bursary cancellation via your MyNSFAS account.

*** A STUDENT CANNOT RECEIVE MORE THAN ONE GOVERNMENT FUNDING OPTION**, nor can a student receive a full-cost bursary from other sources if they are funded by NSFAS

DEFUNDING by NSFAS.

- NSFAS reserves the right to withdraw funding *at any time* if you are found to be ineligible.
- Ineligibility may result due to a change in financial circumstance, academic results, and/or missing documents.
- CUBL compiles provisionally funded lists based on the data from NSFAS, which means your funding status* could change (see point above).

Please understand that SU (and CUBL) is only the administrator of the NSFAS DHET bursary and cannot be held liable for changes in funding status. Any funding decision queries must therefore be directed to NSFAS.

If you become defunded, you will be able to appeal within a specific timeframe. The appeal process is only managed by NSFAS, not CUBL.

*** IT IS YOUR RESPONSIBILITY** to carefully monitor your status on your myNSFAS account and respond in time when requested by NSFAS

SU FUNDING opportunities.

- All prospective and current NSFAS-funded students *must also apply for SU funding**, so you are registered on the CUBL database and can then be considered for gap funding (costs not covered by NSFAS allowances, including emergency and/or graduate debt funding).
- Should you for any reason become defunded (funding withdrawn), and/or your appeal is unsuccessful, you will also be registered with SU for funding consideration.
